#### I. Opening

Bonnie reached obtained a list of members who've indicated that they enjoyed photography and will ask that they begin the process in using their talents to collect photos for this dedicated board.
- d. Church Website – Tim shared recent statistics on site visits to our Church website through May. No action taken.
- e. Welcome Folders – It was further discussed, as earlier suggested, to mount the 'Welcome Folders' into a rack connected to the guest registry stand for easier access. Each committee member will search for ways in hopes of accomplishing this. No formal action taken.
- f. Second Set of Greeters – Discussed in brief. No action taken.
- g. "Everyone His Witness" – This new Evangelism tool was discussed. The materials were purchased and a short introductory video was presented. The church office will proceed with obtaining grant funding covering half the cost. General consensus of the committee was to ask church Council members and then members attending the upcoming Voters meeting in July in first consideration of collecting the initial 12 participants.

#### V. New Business

- a. The Evangelism Committee was approached by a congregational member to consider the possibility of inviting Michelle DeRusha, author of the book "*Katharina and Martin Luther: The Radical Marriage of a Runaway Nun and a Renegade Monk.*" While committee members had not read the book, but the fee for the presentation covered by a pair of congregation members, it was decided to first look into possible LCMS connected reviews of this work first. Pastor Toensing was asked to research what he could and perhaps weigh in on any likely opportunity.
