THE WONDERFUL WORKS OF GOD: THE LAW

We hear them telling in our own tongues the wonderful works of God (Acts 2:11).

In order to rightly hear the Bible and preaching, every Christian should have a basic understanding of the distinction between Law and Gospel. In short, the Law is whatever God wants us to do; the Gospel is whatever God does for us in Christ. This month, we'll focus on the Law.

The first mistake one could make is to think Law = Bad, Gospel = Good. On the contrary, the Law of God is good and wise (see Psalms 19 and 119). The Law shows us God's will for our lives. God's Law is good for us. For example, God values life, so he prohibits murder in all forms. God values marriage, so he wants us to honor and protect it. God is not out to ruin our fun or be a cosmic killjoy. In fact, God is the very giver of joy and all good things.

Because of sin, however, our hearts and minds are corrupted and upside down. The Law brings the knowledge of sin (Rom. 3:20). In telling us what we should do, it also points out that

we haven't done it, not all the time, not all the way, and not with our whole hearts. This is the main purpose of the Law. It exposes our sin and need for a savior. Without the Law we wouldn't understand our need for the Gospel. The Law itself is good, but it is bad news for sinners. Only in the Gospel can we sinners find the Good News we need.

The Law restrains the wickedness of man so that we do not utterly destroy ourselves. It shows our sin and teaches us what we are supposed to be doing. Christians need to hear the Law preached because we need to be reminded of our need for a savior but also because we need to learn more about God's will for our lives. Unless people are taught, they will not automatically from their Baptism know that abortion kills a baby. It just isn't obvious to everyone apart from the clear Word of God. Sadly, when God's Law is ignored then all fear of God and accountability for our actions is also ignored. Sadly we see this in our world and in our own hearts.

Another big mistake is to think that the Law can save or help us become saved. We see problems

around us and are tempted to think: "If we could only get people to shape up and behave, then things would be better." They might be, but only on the outside and only for a short while. Hearts would still be far from God, and sinners would still be without a savior. The Law can never save. It always condemns sinners.

Take the example of speeding. If we are driving too fast and see a police officer (the Law) what will we do? We'll slow down, of course, but only for a short while. Soon we will be back to speeding if that is our heart's desire. The Law can change our outward behavior for a while, but it doesn't change the attitude in our heart. Only the Gospel of Jesus dying for us can change our hearts and convert us to God.

Thanks be to God the Law is not his only or final word. He also gives us the Gospel of our Lord Jesus Christ!

President Terry Dittmer called the meeting to order at 8:05 pm.

Pastor Hayes led us in an opening prayer.

Rollo Schulz made a motion to accept Cheryl Langfeldt and Gloria McDermott as new members. Seconded and passed.

Minutes of the October 27, 2014 Voters Meeting were read and approved.

A transfer of \$1,909 from the Lillian Hackstock memorial was made to pay for paramounts and vestments and \$20,907.29 was transferred in to pay for the remaining balance on the parking lot, cemetery and roof. The general budget still needs to be repaid \$8,011.27 for the roof and cemetery. The Thanksgiving service offering of \$634 was sent to Crete Cares. Brent Wohl made a motion to accept \$13,789.66 as the mission pledge for 2015 which is 10% of the 2014 receipts. Seconded and passed. Glen Louch made a motion to give \$400 of the money received from the 2014 Children's Christmas Program, Christmas Eve services and Christmas Day service to Lutheran Family Services. Seconded and passed. Troy Henning made a motion to accept the Treasurer's Report as given. Seconded and passed.

Pastor's Report:

Pastor would like to thank all the officers who are finishing up, the officers that are continuing on and our newly-elected officers. He reported there are 423 total baptized members on the roster and 265 active members. There have been an average of 116 members present on Sunday mornings and an average of 16 members attending the Wednesday even-

ing services. The Wednesday evening average total doubles during Lent and Advent. Ash Wednesday is February 18. The theme for the Lenten services is the 7 Penitential Psalms. Lenten services will be at 10:30 am and 7:30 pm. Please pray for Pastor Hayes and his family as he is always praying for all of us.

Board of Education:

Pastor reported that midweek is going well but there has been low attendance for Sunday School. VBS planning will start soon.

Trustee's Report:

Dolyn Meinke reported that the cemetery fence is installed. Dean Prochnow is working on the burial plot maps on the computer. The cemetery gate sign that was rebuilt by Brent Wohl and painted by the youth group is ready to be put back up. The fence around the air conditioner has been straightened. General maintenance has been done.

Youth Report:

Ashley Walker reported that in October they had a lock-in with a snowball fight. Their Halloween party was attended by 20-30 kids. In November they sold apple, pumpkin and pecan pies for Thanksgiving. In December they decorated the church for Christmas. An upcoming event is the Valentine's Dinner on Sunday, February 15. Abbie Reitz was selected as head usher and Garrett Reitz was selected as assistant usher. Ashley, Jeana and the youth would like to thank the congregation for their continued support throughout the year.

Evangelism Report:

Carol Brinkmeyer reported that the visitation program is set up – there are 6 members which consists of 3 Evangelism committee members and 3 church members. They are working on the new member packets. They are trying to figure out what to include in those packets. The visitor packets are done and are being handed out on Sundays. When they are done working on making revisions on the church directory it will be given to Cathy to distribute. They would like to do a pictorial directory. Pastor and Cathy will get estimates from different companies pertaining to the pictorial directory.

Memorial Report:

Dolyn Meinke reported that all families have been called and all but three (Lillian Hackstock, Gladys Schlichtemeier, Lisa Dello) have put their money towards paying for the concrete and roof.

There was a tie among the nominees of the Cemetery Committee. Terry Dittmer motioned to accept all three nominees on the cemetery committee. Seconded and passed. Pastor reminded all newly elected and continuing committee members that the Installation of Officers will be this Sunday, February 1, 2015.

Old Business:

Dean Prochnow is working on the burial plot maps.

New Business:

A letter from Rev. Christopher Ahlman was read thanking us for actively supporting his mission.

For the staff salary discussions, Pastor and Jolene Reetz were excused from the meeting. Terry presented to the voters the salary recommendation from the Council for the church secretary, organist/pianist and the custodian's salaries which is a 1.4% increase for the organists and custodian. They are as follows:

Secretary – currently \$750 monthly – will remain the same

Organist/pianist – currently \$60 per service – increased by \$3 to \$63 per service

Custodian – currently \$435 monthly – increased by \$10 to \$445 monthly
Discussion followed. Lee Miller made a motion to accept the Council's recommendation on the salaries. Seconded and passed.

Then Terry presented the Council's recommendation for Pastor's salary which is as follows:

His current salary is \$36,000 – the council recommends a salary of \$36,500 which came from the recom-

mended base salary from the Synod for 2015 of \$31,510 with the following additions: \$1,600 for years of service (4) at \$400 per year, \$900 for advanced degree credit hours (30 hours at \$300 for every 9 credit hours) and \$2,490 for meritorious service. His education allowance of \$500 annually and housing allowance of \$540 monthly will stay the same. Pastor's HSA account was funded at \$3,000 for 2014. The council recommends \$4,000 for Pastor's HSA for 2015. Discussion followed. Delbert Reiss made a motion that we increase Pastor's salary to \$36,500 and increase his HSA account to \$4,000. Seconded and passed.

Resolved, that St. John Lutheran Church, as a standing resolution to remain in force and effect until such time as amended or revoked, hereby authorizes and establishes a housing allowance for Pastor Joshua Hayes at any time serving it in the amount of \$6,480 per year.

John Reitz will spearhead the Auditing Committee. The other two members will be finalized within the next week.

Roll Call showed 36 members present and 4 guests. Meeting closed with the Lord's Prayer at 9:20 pm.

HEALTHY HABITS: I'VE FALLEN AND I CAN'T GET UP!

With winter weather still amongst us, it is important to address the prevention of falls on slick sidewalks and snow covered driveways, however there are other potential causes of falls that warrant to be addressed. Although a simple fall may seem harmless, the potential injury from a fall can be devastating. Let's look at the statistics:

- 1 out of 3 adults aged 65 and older have a fall each year.
- Falls are the leading cause of fatal and non-fatal injuries amongst older adults
- Fall-related fractures among women are more than twice those for men.
- Men are more likely than women to die from a fall.
- Over 95% of hip fractures are caused by falls. 1 in 5 hip fracture patients die within a year of their injury. 1 in 3 patients with a hip fracture who lived independently before the fracture remain in a nursing home or rehab facility a year after their fracture.
- In 2012, the average cost of a hospital stay for a fall injury was over \$34,000.

Ideas in which may be helpful to prevent falls are:

- When getting up from a sitting position, get up slowly and take a few moments to get your bearings before walking.
- Exercise regularly and include in your exercise mild weight bearing exercises.
- Have your eyes checked
- Reduce hazards in your home like installing grab bars in your bathroom, railings at stairways, getting rid of your throw rugs, walk with good shoes on while preventing from walking bare footed around your home, and improve the lighting in your home.

Accidents are not the only cause of falls. There may be other health conditions that may be contributing to a fall. In this instance, **please** talk to your doctor. So many times, many people who fall are fearful for discussing this with their doctor and family. **Prevention** is incredibly important as the potential outcome from a fall can be life changing.
